Clearance advice and/or guidance by thinktv <u>is not legal advice</u> and that we are <u>solely responsible for obtaining our own legal advice</u> in respect of the PSA to ensure that the PSA and any media platform, including without limitation, websites and apps, referred to in the PSA are in full compliance with all applicable legislation and codes.
- 3. The PSA does not infringe copyright or other intellectual property or proprietary interest of any third party and the airing of such PSA is and will continue to be in compliance with all applicable laws in the province or territory where the PSA is to be broadcast.
- 4. We are a not for profit organization duly and validly incorporated under applicable provincial or federal laws of Canada. We have the requisite right, power and authority to enter into this agreement.
